INTRODUCTION

The Land Transport Regulatory Authority (LATRA) is a Government Regulatory Authority established by the Act No. 3 of 2019. It is set to regulate Road Transport Services for goods and passengers (commuter buses, intercity buses, taxi cabs, ride hailing, ride sharing, motor cycles, motor tricycles and goods carrying vehicles); Railway transport services; and other forms of Land Transport like Cable Transport. According to section 5(g) of the Act, the Authority is mandated to monitor the performance of the regulated sectors. This report provides statistics on the performance of road sector for the period of April-June of the FY 2021/2022 compared to the same period of FY 2020/2021.


ROAD TRANSPORT SERVICES

The Authority continued issuing road transport service licenses for passenger and goods carrying vehicles to ensure they meet licensing standards. To effect this, the Authority issued a total of 65,128 road service licenses, equivalent to an increase of 23.8% compared to the licenses issued in the similar quarter of the financial year 2020/21. Table 1 and figure 1 below show categorically total number of road licenses issued in Quarter four of the financial year 2021/2022.

PASSENGER SERVICE VEHICLES

Public service vehicles includes commuter and intercity buses licensed under regulation 4 of the Transport Licensing (Passenger Service Vehicles) Regulations, GN 76 of 2020.


Figure 2: Licenses for Passenger Service Vehicles per category

The Authority issued a total of 12,281 licenses for passenger service vehicles (PSV), indicating an increase of 21.5 percent compared to 10,107 issued in the similar period in FY 2020/21. The licenses issued for PSV contributes about 18.9 percent of the total issued licenses. Table 2 and Figure 2 show the number of licenses issued to passenger vehicles per service category. Moreover, Table 3 and Figure 3 show the number of issued passenger vehicles per class of service.

GOODS CARRYING VEHICLES

Goods carrying vehicles are licenced under regulation 3 of the Transport Licensing (Goods Carrying Vehicle) Regulations, GN 77 of 2020. A total of 37,818 licenses were issued by the Authority for Goods Carrying Vehicles (GCV) during quarter four of the financial year 2021/2022, reflecting an increase of 19.5 percent compared to 31,635 licenses issued during the similar


period between April to June, 2021.

The licenses issued for GCV contributes about 58.1 percent of the total issued licenses. Table 4 and Figure 4 show the number of issued GCV per carrying capacity.

MOTORCYCLES AND TRICYCLES

Motorcycles and tricycles are means of transport licensed under regulation 4 of the Land Transport Regulatory Authority (Private Hire Services) Regulations, GN 78 of 2020. These Regulations shall apply in relation to public hire vehicles with carrying capacity of below fifteen passengers and shall include motor cycles and motor tricycles.


Motorcycles

The Authority issued a total of 7,470 licenses (D1) for motor cycles being an increment of 57.7 percent when compared

to a total number of 4,737 licenses issued during the similar period of the previous financial year. The total number of licenses issued for motor cycles during the Fourth Quarter of FY 2021/22 contributes about 11.5 percent of total licenses issued by the Authority.



Figure 5: Licenses issued to motorcycles in FY 2021/22 Vs 2020/21




Tricycles

During the period under review the Authority issued a total of 6,319 Licenses (D2) for motor tricycles, recording increment of 29.0 percent when compared to a total of 4,897 licenses issued in similar period last financial year. Licenses issued to tricycles contributes about 9.7 percent of the total licenses issued during the period under review.



Figure 6: Licenses issued to Tricycles in FY 2021/22 Vs 2020/21




TAXI

Taxi are licensed under regulation 4 of the Land Transport Regulatory Authority (Private Hire Services) Regulations, GN 78 of 2020. They are commercial vehicle for private hire purposes. They have several categories namely; taxi cab, ride-hailing services and ride-sharing services.

Taxis (Conventional)

The Authority issues a total of 675 licenses for, conventional taxis, recording an increase of 132 percent when compared to 291 licenses issued in similar previous financial year. Licenses issued to conventional taxes contribute about 1.0 of the total licenses issued during the period under review.

Taxis (Ride Hailing)

During the reporting period, the Authority issued a total of 565 licenses for ride hailing taxi services, recording a decline of 40.1 percent when compared to a total of 943 licenses issued in similar period last financial year. Licenses issued to ride hailing taxi services contributes about 0.9 percent of the total licenses issued during the period under review.

More details of the issuance of licenses are provided in Table 1 and Figure 1 above.

DRIVERS REGISTRATION

The procedure for drivers' registration

and certification is covered under regulation 4(1) of the Land Transport Regulatory Authority (Certification of Commercial Vehicle Drivers and Registration of Crew) Regulation, GN. 81 of 2020. The Authority started registration of the drivers for the

purpose of certifying their competence, skills and knowledge to increase road safety and reduce accidents.

Total Registered Drivers

The authority conducted registration of the drivers for the purpose of certifying their competence, skills and knowledge. A total of 10,306 drivers have been registered from December, 2020 to date.
