## 1.0 INTRODUCTION

The Land Transport Regulatory Authority (LATRA) is established under section 4 (1) of the Land Transport Regulatory Authority Act, 2019 (Cap. 413). The Act provides mandate for LATRA to regulate Road Transport Services for goods and passengers (commuter buses, intercity buses, taxi cabs, ride hailing, ride sharing, motor cycles, motor tricycles and goods carrying vehicles); Railway transport services; and other forms of Land Transport like Cable Transport.

This First Quarter report provides a summary on licenses issued to all categories of road transport vehicles regulated by the Authority in the Financial Year 2022/2023 compared to the financial year 2021/2022. It further serves as a reference material for land transport regulatory and services performance to the Authority and public at large.

## 2.0 ROAD TRANSPORT SERVICES

The Authority is vested with powers under Section 5 (1) (a) and (b) of LATRA Act, CAP 413 of 2019 to perform the functions conferred to it by sector legislations including issuance, renewal and cancelling of permits and license. Moreover, the Authority monitors the performance of the regulated sectors including levels of investment; cost of services; efficiency of production and distribution of services and other matters relevant to the Authority.

### 2.1 Total Issued Licenses

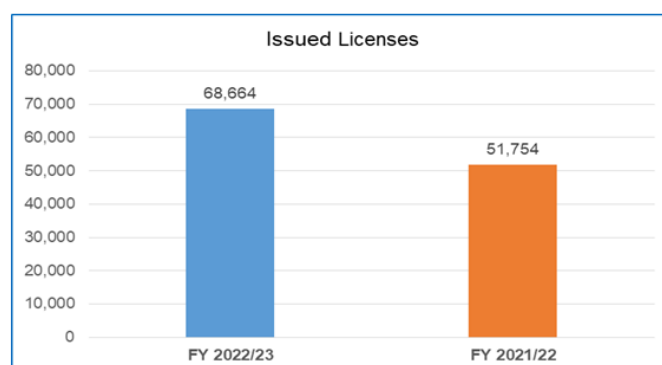
The Authority continued issuing road transport service licenses for passenger and goods carrying vehicles to ensure licensing standards are met. To effect this, during the period under review, the Authority issued a total of 68,664 road service licenses, equivalent to 32.7 percent increase compared to number of licenses issued in the same period of the financial Year 2021/2022. Table 1 and Figure 1 summarizes.

## 3.0 ISSUED LICENSES BY SERVICE CATEGORY

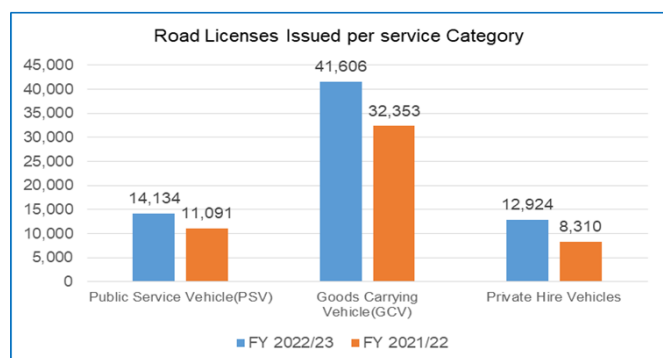
During the first quarter of the financial year 2022/2023, number of licenses issued to Public Vehicles, Goods Carrying Vehicle and Private Hire Vehicles increased by 27.4 percent, 28.6 percent and 55.5 percent respectively. Licenses issued to Goods carrying vehicles were 60.6 percent of all issued licenses in the reporting period. Table 2 and Figure 2 provides a clear picture.

### 3.1 Public Service Vehicles (PSV)

Public service vehicles include commuter busses, intercity & regional buses, school busses, tour busses and school busses licensed under regulation 4 of the Transport Licensing (Passenger Service Vehicles) Regulations, GN 76 of 2020. The share of passenger service vehicle licenses was about 20.6 percent of the total issued licenses during the period.

### 3.2 PSV per License Category

During the first quarter of the financial year 2022/2023, the Authority issued 14,134 licenses for public service vehicles, equivalent to 27.4 percent increase compared to 11,091 public service vehicle licenses issued in similar period of the FY 2021/2022. Further, majority of licenses issued to operate public service vehicles were Inter-city & Regional busses (49.6 percent) followed by commuter buses (23.3 percent). Table 3 shows number of licenses issued in each category of public service vehicles.

### 3.3 Issued PSV per Sitting Capacity

During the reporting period, 37.8 percent of licenses issued to public service vehicles had sitting capacity of 15 sitters or below, followed by 32.0 percent sitting capacity of 26 to 45 passengers. Licenses issued to vehicles above 65 sitters were 1.0 percent of total, Table 4 summarizes.

#### 3.3.1 Intercity and Regional Busses per Class of Service

Passenger service vehicles are classified according to class of service. In this categorization, there are ordinary, lower semi-luxury, semi-luxury as well as luxury vehicles depending on the availability of sophisticated services as determined by licensing conditions. During the reviewed period, 91.7 percent of issued licenses of Intercity and Regional Busses were ordinary class as summarised in Table 5.

#### 3.3.2 Intercity and Regional Busses per Carrying Capacity

During the period under review, 33.5 percent of licenses were issued to intercity and Regional passenger busses with a sitting capacity of up to 15 sitters, followed by 30.0 percent sitting capacity of 26 to 45 passengers. 22.0 percent licenses were issued to vehicles with sitting capacity of 16 to 25 passengers, 13.9 percent licenses were issued to vehicles with sitting capacity of 46 to 65 passengers and 0.6 percent to vehicles with sitting capacity of above 65 passengers. ### 3.3.3 Issued Licenses for Commuters per Carrying Capacity

In the reporting period, 45.9 percent of licenses were issued to commuter busses with capacity of 26 to 45 passengers, followed by 34.4 percent sitting capacity of between 16 to 25 passengers. 19.1 percent licenses were issued to vehicles with sitting capacity of up to 15 passengers. ### 3.3.4 Issued Licenses for Tours Busses per Carrying Capacity

During the first quarter, 96.1 percent of vehicles offering tour services had a sitting capacity of up to 15 passengers, followed by 2.4 percent sitting capacity of 26 to 45 passengers and 1.5 percent licenses were issued to vehicles with sitting capacity between 16 to 45 passengers. ### 3.3.5 Issued Licenses for School Busses per Carrying Capacity

According to Regulation 4 of the Transport Licensing (Passenger Service Vehicles) Regulations, GN 76 of 2020, School bus means a passenger service vehicle, whether owned or operated by a registered day care centre, school or privately owned or operated under contract with such school, which is intended to provide transport services to pupils to or from school, or for any other school related activity, when they are in a group.

During the reporting period, 46.3 percent of licenses were issued to school busses with capacity of 26 to 45 passengers, followed by 30.7 percent sitting capacity of 16 to 25 passengers. Table 9 below details.

### 3.3.6 Issued Licenses for Staff Buses per Carrying Capacity

According to Regulation 4 of the Transport Licensing (Passenger Service Vehicles) Regulations, GN 76 of 2020, Staff bus means a passenger service vehicle intended to provide transport services to employees or students. During the reporting period, 45.7 percent of licenses were issued to staff buses with capacity of 26 to 45 passengers, followed by 37.0 percent sitting capacity of up to 15 passengers. Table 10 below details.

### 3.3.8 Public Vehicle Licenses Issued per Zone

During the first quarter, out of the total 14,134 issued licenses, 32.7 percent were issued in the Eastern Zone, followed by 28.9 percent of licenses that were issued in the Northern zone. Licenses issued to the Central zone in first quarter of the financial year 2022/23 increased by 45.0 percent compared to the financial year 2021/22. Table 12 below details.

## 4.0 GOODS CARRYING VEHICLES

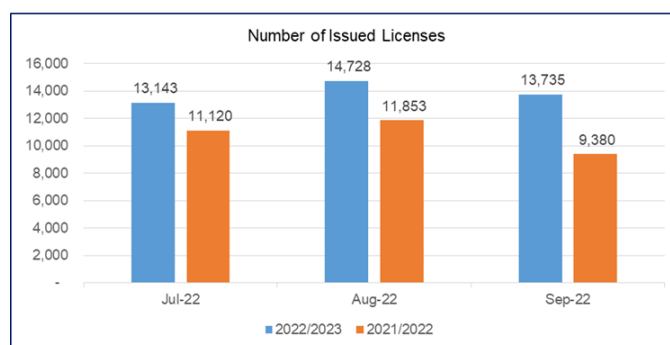
Goods carrying vehicles are licenced under regulation 3 of the Transport Licensing (Goods Carrying Vehicle) Regulations, GN 77 of 2020. A total of 41,606 licenses were issued to provide services as Goods Carrying Vehicles (GCV) during the first quarter of the financial year 2022/2023, reflecting an increase of 28.6 percent compared to 32,353 licenses issued during the similar period in the preceding financial year, Table 13 and Figure 3 details.

### 4.1 Goods Carrying Vehicles per Carrying Capacity

It was noted during the reporting period that, 29.4 percent of GCV licenses were issued to large trucks with carrying capacity of 31 tones and above. The highest number of licenses 32.4 percent were issued to trucks with carrying capacity between 6 and 10 tones. The smallest number of licenses issued was 0.6 percent, issued to trucks with carrying capacity between 26 and 30 tones. More details are provided in Table 14

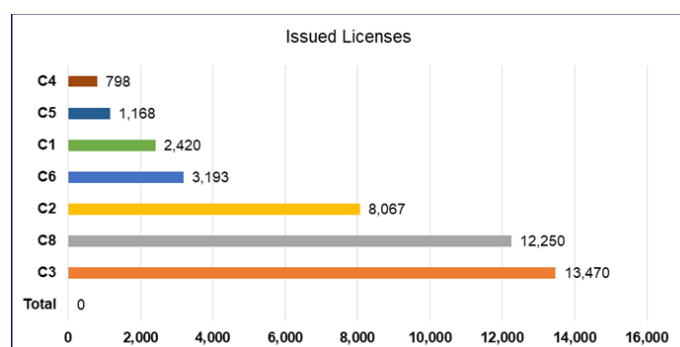

## 4.2 Goods Carrying Vehicles per Zone

During the first quarter, out of the total 41,606 issued licenses, 50.0 percent were issued in the Eastern Zone, followed by 15.9 percent of licenses that were issued in the Southern zone. Licenses issued to the Southern zone in first quarter of the financial year 2022/23 increased by 67.6 percent compared to the financial year 2021/22. Table 15 below details.

During the first quarter, 57.4 percent of issued licenses for goods carrying vehicles were owned by companies and 42.6 percent by individuals. Table 16 below details.

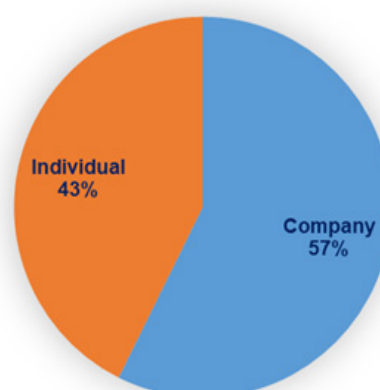

## 5.0 PRIVATE HIRE SERVICES

Private Hire services includes Motorcycles, Motor tricycles, Taxi Cabs, Ride Hailing, Ride sharing and Special Hire. Private Hire services are licensed under regulation 4 of the Land Transport Regulatory Authority (Private Hire Services) Regulations, GN 78 of 2020.

### 5.1 Motor-cycles (D1)

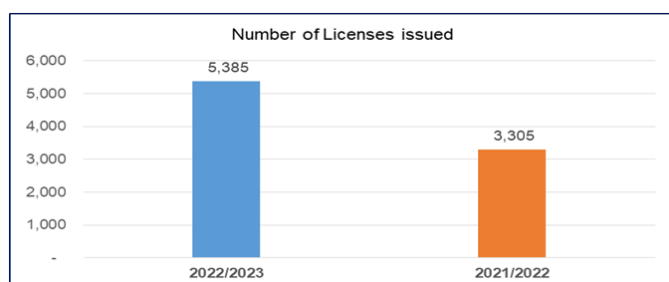
The Authority issued a total of 5,385 licenses (D1) for motor cycles in quarter one of the financial year 2022/2023, being an increase 62.9 percent compared to a total number of 3,305 licenses issued during the similar period of the previous financial year. The licenses issued for motorcycles contributes about 7.8 percent of total issues licenses during the reporting period, Table 17 and Figure 6 summarizes.

**Figure 6: Licenses issued to Motor Cycles in Quarter One-2022/23 vs 2021/22**

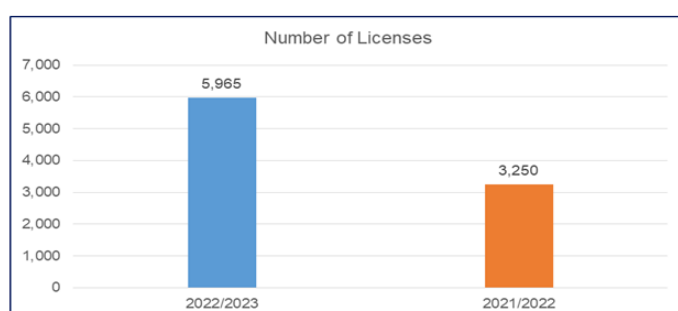

## 5.2 MOTOR TRICYCLES

During the period under review the Authority issued a total of 5,965 Licenses (D2) for motor tricycles, recording a growth of 83.5 percent compared to a total of 3,250 licenses issued in similar period of the financial year 2021/2022. Licenses issued to tricycles contributes about 8.7 percent (refer Table 1 and Figure 7) of the total licenses issued during the period under review.

## 5.3 Motorcycles and Motor-Tricycles per Zone

During the period under review, number of licenses issued to motorcycles in the Central zone, Eastern Zone, Lake Zone, Northern Zone and Southern Zone increased by 71.4 percent, 107.8 percent, 16.3

percent, 3.3 percent and 26.5 percent respectively, as compared to the same period of the previous financial year.

Moreover, number of licenses issued to motor tricycles in Central zone, Eastern Zone, Lake Zone, and Southern Zone increased by 7.5 percent, 399.3 percent, 31.4 percent and 45.4 percent as compared to the same period of the previous financial year. On the same period, number of licenses issued to tricycles in Northern zone declined by 25.0 percent. Table 18 below details.

## 5.4 TAXI-CABS (D3)

Taxi-cabs are licensed under regulation 4 of the Land Transport Regulatory Authority (Private Hire Services) Regulations, GN 78 of 2020. They are commercial vehicle for private hire purposes. They have several categories namely; taxi cab, ride-hailing services and ride-sharing services.

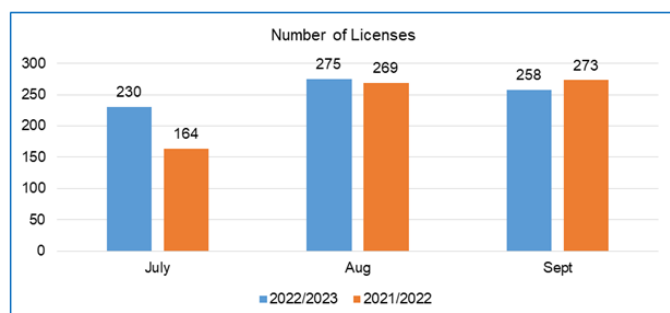

## 5.5 Ride Hailing

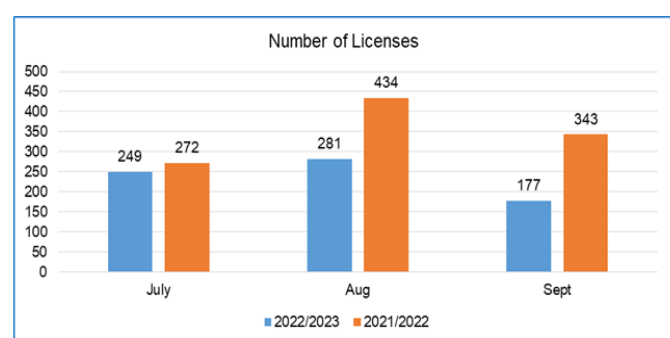

## 6.0 REGISTRATION AND CERTIFICATION OF DRIVERS

The procedure for drivers' registration and certification is covered under regulation 4(1) of the Land Transport Regulatory Authority (Certification of Commercial Vehicle Drivers and Registration of Crew) Regulation, GN. 81 of 2020. The Authority commenced registration of drivers for the purpose of certifying their competence, skills and knowledge to increase road safety and reduce accidents.

### 6.1 Total Registered Drivers

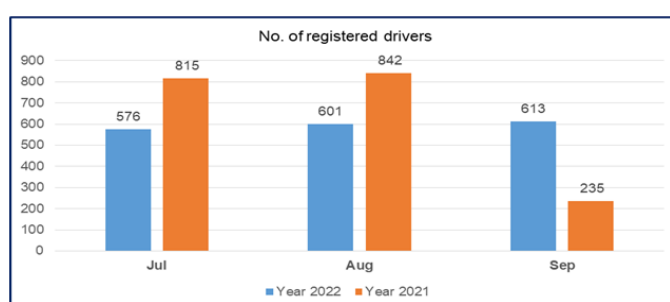
During the quarter, the Authority registered a total of 1,790 drivers which shows a decline of 5.4 percent compare to 1,892 drivers registered during the same period in the financial year 2021/2022. The purpose of registering is to certifying their competence, skills and knowledge. More details are provided in Figure 10 and Table 21.

### 6.2 Number of Examined Drivers

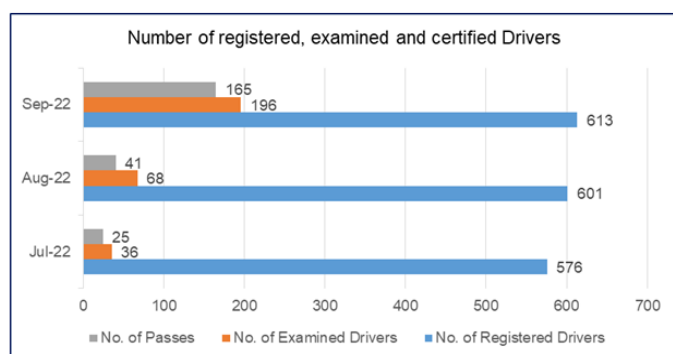

**Figure 11: Number of Registered, Examined and Certified drivers**



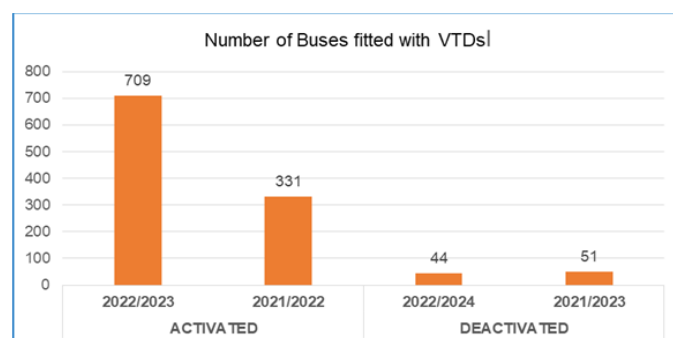

## 7.0 Vehicles Installed with Vehicle Tracking Devices

The Transport Licensing Act (CAP. 317) section 45 defines Vehicle tracking Device as a device and its accessories installed in a public service vehicle capable of transmitting its recordings in real time to the Vehicle Tracking System (VTS).

The Authority started installation of VTDs for the purpose of monitoring licensed vehicles through Vehicle Tracking System to access compliance of speed limits in order to enhance road safety.

During the first quarter of the Financial Year 2022/2023, a total of 709 buses were fitted with Vehicle Tracking Devices (VTDs), recording an increase of 114.2 percent compared to a total of 331 buses fitted with VTDs in the similar period of the previous financial year. However, during the similar period, a total of 44 buses were deactivated, recording a decline of 13.7 percent compared to a total of 51 buses deactivated in the similar period of the preceding financial year.
