**1.** These Regulations may be cited as the Transport Licensing (Public Service Vehicles) (Amendment) Regulations, 2026 and shall be read as one with the Transport Licensing (Public Services Vehicles) Regulations, 2020 hereinafter referred to as the “principal Regulations”.
